CONDITIONS OF SERVICE

1. Prior to the stud service, the bitch owner will provide the following information about the bitch to the stud dog owner via email, mail, or fax:

- Negative brucellosis test dated within 10 days of a natural breeding
- Copy of AKC pedigree
- Copy of normal OFA hip report
- Copy of normal OFA elbow report
- Copy of normal CERF report
- Photograph of bitch

- Copy of CNM report
- Copy EIC report
- Copy of up-to-date shot records with dates if natural breeding:

2. The stud owner will NOT be held liable for injuries that may be sustained by the bitch during the breeding process or while on the stud owner's or trainer's property.
3. The bitch owner agrees to perform progesterone and/or LH testing on the bitch to determine the proper breeding window. The bitch owner will be responsible for any and all medical expenses, including those pertaining to hormone testing and veterinary fees. If a natural breeding cannot be accomplished, and the bitch owner desires to proceed with an AI breeding, the bitch owner agrees to provide a credit card number to the collecting veterinarian to cover any AI costs, and to pay any travel fees incurred to transport the bitch to the AI facility.
4. The stud fee is \$2,000 or pick of the litter for bitches with advanced titles or approved pedigrees. A \$500 non-refundable deposit is to be paid at the time of the breeding or prior to shipping fresh-chilled or frozen semen. This deposit will be applied to the stud fee. The remainder of the stud fee is due within two weeks of the whelping of the litter. After full payment has been made, the stud dog owners will sign the litter registration.

Any or all of the following breeding methods may be used, by agreement of the parties and with payment of all costs and charges for such methods as described below.

- A. **Natural breeding.** The stud fee covers a one-tie natural breeding. Additional ties might be possible if the stud dog's schedule allows, subject to approval from the owner of the stud dog.

If the bitch does not conceive on the first (natural) service, ONE additional service may be provided within the next 18 months subject to the availability of the stud dog. The \$500 non-refundable breeding fee will be waived this one time because of previous payment. The bitch owner may substitute another bitch, provided that she meets the requirements of the agreement. NOTE: This is only in the case of a natural breeding.

If fewer than three live puppies are whelped from a natural breeding, the stud fee will be adjusted to \$500 per puppy. There is no adjustment for a fresh-chilled or frozen semen breeding.

- B. **Side-by-side.** The stud fee covers one collection. Additional collections might be possible if the stud dog's schedule allows, subject to approval from the owner of the stud dog. The \$500 non-refundable deposit will be paid prior to the breeding process. All expenses relating to the collection of semen and the insemination of the bitch are the responsibility of the bitch owner.
- C. **Fresh chilled.** The bitch owner will be responsible for all travel expenses of the stud owner if incurred, as well as veterinary expenses and shipping. The bitch owner agrees to provide a credit card number to the collecting veterinarian to cover any costs. Semen will not be shipped without receipt of the \$500 non-refundable deposit.
- D. **Frozen.** Frozen semen is stored with Zoetis. When deposit is received, the stud owner will release semen equal to one breeding. The bitch owner will receive an email from Zoetis with instructions on how to arrange shipping.

Cost for shipping and handling will be paid directly to the semen bank. AI veterinarian cost will be the responsibility of the bitches' owner. Semen will not be shipped without receipt of the \$500 non-refundable deposit.

NOTE: Because fresh chilled and frozen semen can be examined for viability, there is no guarantee or adjustment of fees if the breeding fails or the litter size is less than 3 puppies.

- 5. The bitch owner agrees that no puppy produced as a result of this breeding will be sold to a pet shop, agent or broker.
- 6. The owners of the stud dog are not obligated to sign an application for litter registration with the AKC, nor may such application be made, until and unless all applicable terms stated above have been met.
- 7. If the bitch's owner(s) fail to fulfill the conditions of this contract, the bitch's owner will be responsible for reasonable attorney's fees if action is taken by the stud dog owner on behalf of the bitch that was bred and/or puppies produced from this breeding.

After reading the above terms and conditions, we find them mutually agreeable and acceptable.
